Amanda Green-Hawkins for PA Superior Court

One of Pennsylvania's two intermediate appellate courts, the Superior Court is famously America's busiest court, requiring judges with wide-ranging knowledge who can make decisions quickly, but without sacrificing thoughtfulness or compassion for the litigants. Green-Hawkins has years of proving her work ethic and concern for all people as a labor lawyer with the United Steelworkers; in public service as an Allegheny County councilperson and Port Authority board member; and in community work as a board member for Women for the Future of Pittsburgh, the Women's Law Project, and the Rules and Bylaws Committee of the Democratic National Committee. Mary McGinley for Common Pleas Court

The Court of Common Pleas is Pennsylvania's trial court of general jurisdiction. McGinley has appeared regularly before that Court's Civil and Orphans' Court Divisions. The Orphans' Court handles estates, issues relating to public charities, and lawsuits where a party is unable to represent their own interests competently, making it vitally important for ensuring that the interests of children, people with disabilities, and people in need of charitable services are fully represented.
